RULES & REGULATIONS

- All anglers must have a valid Florida fishing license.
- Payout based on paid boat field. If boat field is not met, prize structure will be based on 100% paid boat entries.
- Entry Fees: Boat division \$200 (\$175 early registration through Jan 31), Kayak division \$100 (\$75 early registration through Jan 31)
- Registration closes at 6:30pm on Friday, April 14, 2023.
- This is a live and artificial bait tournament.
- Captain's meeting and raffle giveaways will be hosted at 6:30pm at St. Augustine Fish House and Oyster Company at 160 Nix Boat Yard Rd, St. Augustine, FL 32084 on Friday, April 14, 2023
- Captain's meeting is mandatory for one of the team's anglers. Lines in at safe light which will be announced at captain's meeting. This is a boat tournament only. You cannot leave the boat under any circumstances.
- NO fish may be weighed in that are caught on government property that required specific personal identification. This will be enforced under protest.
- In lieu of a tie, we will go with the time the boats or angler weighed in for all divisions.
- All protests are \$300. If a protest is not upheld, protest fee is non-refundable. Polygraph upon protest only.
- **Must be in weigh-in line and registered by 3:00pm.**
- **Weigh in site: Northeast Florida Marlin Club at Comanche Cove 3030 Harbor Dr, St. Augustine, FL**
- Award ceremonies will be at weight in site Saturday, April 15 at 4:00pm.
- **KAYAK DIVISION:** One angler per kayak only. One slot size redfish. Fish does not need to be alive. 1st through 3rd place will be determined by 1 legal fish being weighed per kayak angler by time of weigh in. You may only bring 1 fish to the scales.
- **BOAT DIVISION:** Up to 3 anglers. This is a two fish aggregate tournament, meaning fish must be live at weigh-in. Fish must meet Florida state required size limits (18" - 27"). Fish will be measured using slight tail pinch method. NO fish with mutilated tails will be accepted for weigh-in. If this happens it will be determined by the tournament directors. Fish can be inspected internally to confirm weight at tournament directors' discretion. If 2 fish bag aggregate has any dead fish there will be a 1 lb reduction per each dead fish. 1st through 3rd place will be determined by total aggregate weight of 2 fish at the time the fish bag is weighed in. You may only bring 2 fish to the scales.
- **JUNIOR ANGLER DIVISION:** One Jr Angler may participate as one of the three anglers in a paid boat division registration. Jr. Anglers must pre-register with their boat division in one of three Jr Angler divisions: Age 5-11, Age 12-16, or Powder Puff Age 6-16. They can only win in the division they pre-register for in advance. Only one jr angler per boat. Jr angler must possess their own redfish to weigh in. Winner determined by the heaviest slot size red fish (can't be one of the 2 bag fish aggregates for their boat). Only one legal red fish per entry.
